CDPHP® has a wide range of plan options designed to meet the varying needs of businesses just like yours. This checklist will guide you through the process.

1. Review your plan recommendation.

Enclosed you will find a medical plan recommendation, based on the benefits and cost of your current plan. To review more plan options, review the enclosed packet, contact your broker or CDPHP representative, or visit www.cdphp.com.

2. Consider adding a funding account and/or Healthy Direction programs.

Offering a funding account can help offset out-of-pocket costs for your employees or allow them to use pre-tax dollars to pay for qualified medical expenses. CDPHP offers health savings accounts (HSAs), health reimbursement accounts (HRAs), and flexible spending accounts (FSAs). To help you decide which account(s) is right for your business and your employees, talk to your broker or CDPHP representative.

Healthy Direction programs are free and are available to groups to encourage healthy behaviors. Choose any number of steps for employees to complete and deliver a premium differential or incentive of your choosing. We'll monitor step completion and provide bimonthly reporting. Healthy Direction HSA lets you reward employees with additional HSA funding.

3. Select your Delta Dental plan.

Use the enclosed Delta Dental Plan Selection Form to choose the plan you want to offer your employees. The enclosed plan recommendation will provide a suggestion if you are currently offering this benefit.

Pediatric dental coverage is required by the Affordable Care Act (ACA). If you are providing your employees the essential pediatric coverage from another plan not offered by CDPHP, you must complete the Pediatric Dental Group Attestation section of the enclosed Employer Group Attestations form.

4. Complete the Employer Group Attestations form.

In order to ensure our employer groups are classified and rated accurately, CDPHP requires that all groups attest to their size, as defined by New York law and the ACA.
