Eligible members can use this form to request reimbursement of up to \$1,500 for out-of-pocket costs for in-person or digital doula support services rendered by a certified and/or trained doula.

See your plan contract or call member services at the number on your ID card to confirm that this benefit applies to your plan. Medicaid and Essential Plans are not eligible for this benefit but can receive doula services under the NYS Doula benefit. Visit health.ny.gov/doula to learn more.

Extra support for your pregnancy journey

Eligible members, covered spouses/domestic partners, and dependents can be reimbursed up to \$1,500 for out-of-pocket costs related to in-person or virtual services provided by a certified and/or trained doula who has the appropriate credentials.

FREQUENTLY ASKED QUESTIONS

Who is eligible for this benefit?

- ▶ Subscribers and covered dependents of fully insured commercial plans.
- ▶ Eligibility varies for members of self-insured plans.
- ▶ Spouses, domestic partners, and dependents covered on a CDPHP plan are eligible but should only submit one reimbursement form per pregnancy.

Example: If a spouse already submitted for a \$1,500 reimbursement for a pregnancy, the subscriber cannot submit for reimbursement for the same pregnancy.

Still not sure if you're eligible? Call CDPHP at the number on your ID card.

What is a doula?

A doula is a trained professional who provides continual physical, emotional, and informational support before, during, and shortly after childbirth to help achieve the healthiest experience possible.

Why is a doula helpful during pregnancy and childbirth?

Doula support during pregnancy has been shown to decrease the risk of cesarean and preterm birth, reduce the need for an epidural, decrease the likelihood of having a low birth weight baby or experiencing a birth complication, reduce the length of labor, and improve maternal health equity.

What types of services do doulas provide?

- ✓ Prenatal education classes
- ✓ Childbirth support
- ✓ Pregnancy support
- ✓ Postpartum support

When can I see a doula?

Before, during, and/or after pregnancy and childbirth

How do I know if my doula is certified or has received the appropriate training?

The requirements for certifying a doula varies between doula organizations. Please ask to see a doula's certification or proof of their completed doula training (this may be in the form of a certificate or a letter from the training organization) before seeking services.

Here's some information to look for on a doula certification or training certificate:

- ▶ The doula's name
- ▶ A start date and/or expiration date
- ▶ A certifying or training organization (examples include: DONA, Ancient Song Doula Services, International Black Doula Institute, and more)
- ▶ The hours and type of training the doula received

Some examples of qualifying credentials that your doula may have include:

- ▶ **CD** – certified birth doula
- ▶ **PCD** – postpartum certified doula
- ▶ **Adv. before CD or PCD** – approved as an advanced doula
- ▶ **BDT** – birth doula trainer
- ▶ **PDT** – postpartum doula trainer
- ▶ **DONA** – certified by DONA International

How do I submit for reimbursement?

- ✓ Fill out the doula reimbursement form

What are acceptable proofs of payment?

- ▶ Copy of a bill from the doula showing fee(s) paid or a credit card statement. Doula's name or practice name, amount paid, and date(s) of payment must be included.

Tips for submitting an acceptable form:

- ✓ Check your eligibility and ensure that the Doula Reimbursement Form is completed and signed prior to submitting for reimbursement.
- ✓ Make sure you've submitted proof of payment.
- ✓ Submit for reimbursement up to two times per pregnancy for a total of \$1,500 or less.
